



Results-Based Accountability™

Results-Based Accountability™ (RBA) is a disciplined way of thinking and acting to improve complex social problems – sometimes referred to as wicked problems – and create measurable change in people's lives, communities, and organizations. RBA teaches us to care more about going in the right direction rather than setting unrealistic goals. We embrace "Turn the Curve Thinking" to make decisions about what to do and see if what we do is working.

The NC AHEC RBA course is an introductory course and is highly interactive, offered in an all-day live virtual session OR a blended format with self-paced online pre-work and a half-day live webinar session.

You will be immersed in the RBA framework, its core concepts and characteristics, population accountability and performance accountability, and getting from talk to action through the turn the curve thinking process. You will apply RBA concepts through simulations and see how organizations are using a web-based tool to share data and stories.





This course includes the books **Trying Hard is Not Good Enough** and **Turning Curves** by Mark Friedman.

At the completion of this course, participants will be able to:

- Describe the core concepts of Results-Based Accountability (RBA).
- Recognize key characteristics of RBA.
- Describe the two levels of accountability.
- Identify steps in the Turn the Curve process.
- Discuss the distinction between population accountability and program performance accountability.
- Apply the Turn the Curve decision-making process to your work via simulation.
